### Demonetisation - Success or failure?

### Director's corner



November 8, 2016, the Government of India took a decision to demonetize Rs.500/- and Rs.1,000/- notes which accounted for 86% of the total currencies in the economy. The

administrative machinery, the banking system and the trade at large had to make several adjustments and adapt to alternative measures for each of their day to day transactions. The nation debated continuously on whether Demonetization is going to benefit the economy or otherwise. Political debate led people to confusion and at one point in time, the Supreme Court of India warned of people's outrage if the grievances are not attended to. After completing 55 days, another scenario has emerged wherein it is stated 97% of the demonetized notes have been returned to the Central Bank. There are two claims, which are diametrically opposite, based on this statistic.

It is claimed that Demonetization has been successful in infusing new blood. Their opinion is

that this measure has not made the desired impact on black money. The intention was clear in the context of announcement of demonetized notes made on 8.11.2016. First, the aim of the Government was to block fake money in circulation by unfair means of terrorists outside National Boundaries. Secondly, the domestic splinter groups were to be de-financed. Thirdly, it was desired to liquidate black money in the process of fifty days duration. Has this brought the expected impact?

Secondly, it is claimed that demonetization is a 'monumental disaster'. How true is this statement? A detailed study on assessment of black money after demonetization is the need of the hour. The dramatically projected statements can only then be verified for their authenticity.

# Symposium on Demonetization

"Demonetisation should be seen according to the effect on the economy," says Mr. Arun Jaitley, Union Finance Minister. He adds "...A decision of this kind carries the pain of transition...". "I think India is going to become a society in the long term with a certainly better GDP, cleaner ethics, a cleaner economy". In this context, Bharatiya Vidya Bhavan's M.P. Birla Institute of Management, Bangalore conducted a symposium on 'Demonetization and its Ramifications' on Friday, 16th December 2016. Dr. M R Narayana, Professor of Economics at the Centre for Economic Studies and Policy, Institute for Social and Economic Change, Bengaluru, inaugurated the symposium and delivered the keynote address. The symposium was co-hosted by Sri Subrahmanya Foundation, publishers of 'Southern Economist' journal. Smt. Susheela Subrahmanya Chief Editor, Southern Economist was the Chief Guest of the event which was presided by Dr. N S Viswanath, Director & Principal, MPBIM.

Dr. M R Narayana in his keynote address touched upon various aspects of demonetization illustrating clearly the advantages and pitfalls of the move. Dr.Bisaliah in his talk questioned the timing of the move and felt that India was still not ready for demonetization because of the digital divide. CA Sri. Nithin Mahadevappa pondered on the difficulties of common people and rural folk who are still not in tune with modern technology and use of cards. The speakers felt that an honest criticism would help in taking appropriate corrective measures CA Sri. Rudramurthy supported the Demonetization move and said that the such bold initiatives need to be taken to ensure country's progress. He opined that the cash crunch would slowdown the growth in the coming three quarters. The hardships would have to be endured for a short duration for the country's long term gains. He pointed out that as a result of Demonetization, terrorism from across the borders and with in the country has remarkably come down.

Seven papers were presented at the symposium. Four other papers were submitted by faculty from other colleges. Dr. A.T. Bhashyam, Director. BPBIM, Mysore, gave the concluding remarks. Dr. Rohini G Shetty was the Master of Ceremonies. The student council lent admirable support in conducting the event.
